Superintendent's Report - Bob Callaghan, Superintendent

Congressman Dave Loebsack Visit – May 31, 2017 – Callaghan shared the events of Congressman Dave Loebsack's visit to the district, including stops at the E.J.H. Beard Administration Center and Berg Middle School where he had a Q & A session with staff.

Berg Middle School Ground Breaking Ceremony – June 2, 2017 — Callaghan presented information and pictures from the June 2, 2017 ground breaking ceremony, celebrating the beginning of construction on the new middle school. Exterior and interior drawings provided by FRK Architects + Engineers were also displayed.

Current Student Information – Enrollment Summary: Callaghan reported total student enrollment as of June 6, 2017 at 2,983. Attendance Data: Callaghan shared student attendance percentages at each campus, with ranges from 89.81% - 96.04%. Transiency Report: Callaghan presented a student transiency report for those students who have either left the district, or entered the district since the October 1, 2016 certified enrollment count date.
