Consider Acceptance of the Jasper County Election Canvass of Official Vote Totals for the NCSD School Board Election – ACTION #10266

Gayle Isaac presented the Abstract of Votes cast in the Jasper County school election held September 12, 2017. The canvass of official vote totals was as follows: Robyn Friedman (610); Cody Muhs (556); Travis Padget (588); Graham Sullivan (581). The candidate total was 2,335 votes with a scattering (write-in) of 22 votes, for a total of 2,357 votes.
