Superintendent's Report – Bob Callaghan, Superintendent

Current Student Enrollment

Enrollment Summary – Superintendent Callaghan provided a 2018 – 2019 enrollment update for K – 12 students as K – 4 (1,064), 5 – 8 (912), and 9 – 12 (908) for a total of 2,884 students as of June 4, 2019.

Attendance Data - Superintendent Callaghan shared student attendance percentages at each campus, with ranges from 92.15% - 96.22%

Transiency Report – Superintendent Callaghan presented a student transiency report for those students who have either left the district, or entered the district since the October 1, 2018 certified enrollment count date. The report shows a net decrease of 29 students.
