Superintendent's Report – Bob Callaghan, Superintendent

Principal's Reports – Principals from the elementary, middle, and high schools presented a monthly report on topics including PBIS, Capturing Kids' Hearts, Professional Development, PLCs, assessments, and graduates. Capturing Kids' Hearts training will be held July 17 – 18, 2017 and Leadership Blue Print training will be held July 27 – 28, 2017.

Mentoring and Induction Report – Tara Zehr presented a handbook outlining the goals of the new teacher mentoring program, and explained the duties and training plan for mentors and protégés.

Summer Schedule – Callaghan shared the district's summer schedule for affected employees. The work schedule is Monday – Thursday, with Friday's off from June 5 – July 21, 2017.

Learning, Leadership, and District Business – Bob Callaghan, Superintendent and Gayle Isaac, Director of Business Services Consider Approval of the WEST Academy / K – 12 Curriculum Director – ACTION #10173

Cantu moved, Cook seconded to offer an administrative contract to Bret Miller to serve as Principal of WEST Academy and K – 12 Curriculum Director for the 2017 – 2018 school year. Ayes: Benson, Cantu, Cook, Elbert, Friedman, Leonard, Padget

Consider Award of the 5 – 8 Middle School Construction Project to Hansen Company, Inc. for a Base Bid of \$27,250,000 including Alternate #1 for a Total Contract Amount of \$27,250,000 – ACTION #10174

Dave Briden (FRK Architects + Engineers) presented a tabulation of bids for general construction for the 5 – 8 middle school project. The apparent low bid was submitted by Hansen Company, Inc. Friedman moved, Leonard seconded to award the bid for the construction of our 5 – 8 middle school project to Hansen Company, Inc. for a base bid of \$27,250,000 to include alternate #1 at no change to the base bid contract amount. Sherm Welker (Hansen Company, Inc) expressed his excitement for the project. He feels it was well done, and shared that his team is ready to start on the construction. He shared that they are going to work really hard to bring it in on time, and with good quality results.

Callaghan acknowledged that Hansen Company, Inc. gave us a very competitive bid. He shared that we bonded for \$26.9M and passed a tax rate two cents lower than previous. Callaghan acknowledged the board for being good stewards, while balancing all needs in the Newton Community School District. A formal ground breaking ceremony will be scheduled in the near future.

Consider Approval of the Softball Project Construction Documents and Authorize FRK Architects + Engineers to Receive Bids – ACTION #10175

Dave Briden (FRK Architects + Engineers) presented construction documents for the Newton Softball Complex. This project is to relocate the softball fields from Berg Middle School to south of H.A. Lynn Stadium, due to the expansion of gymnasium space at the new 5 – 8 middle school. Construction on the softball complex would begin July 5, 2017 and be substantially completed by November 15, 2017. The preliminary opinion of project cost is \$831,350.00. Isaac shared that funding for the project would come from sales tax. Leonard moved, Elbert seconded, that we approve the softball field construction documents and authorize FRK Architects + Engineers to receive bids. Consider Approval of the High School Parking Lot Re-Surfacing Project Construction Documents and Authorize Bishop Engineering to Receive Bids – ACTION #10176

David Bentz (Bishop Engineering) presented a project manual for the Newton High School South Parking Lot Reconstruction. The project would begin June 19, 2017 and be substantially completed by August 9, 2017. Cost estimate for the project is \$550,000. Elbert moved, Cook seconded, to approve the Newton High School parking lot re-surfacing project construction documents and authorize Bishop Engineering to receive bids. Ayes: Benson, Cantu. Cook. Consider a Resolution Partnering with the City of Newton and the Department of Natural Resources to Support a Name Change of Sewer Creek to Cardinal Creek – ACTION #10178

Bill Peters (NHS Principal), Courtney Wolken (Science Teacher) and Emily Bollhoefer (Student) were present to explain this ecology project. Cantu moved, Cook seconded that the Newton Community School District approve a resolution supporting Ms. Wolken's Ecology Creek Project and a name change of Sewer Creek to Cardinal Creek. Consider Approval of High School Control Bids – ACTION #10179

Jack Suttek (Maintenance Supervisor) explained the need to remove and replace six air powered pneumatic controls at the high school with digital controls. Suttek presented the bids and the recommendation was to go with Woodman Controls Company. Leonard moved, Cantu seconded that the Newton Community School District accept the bid from Woodman Controls Company in the amount of \$52,335 for the high school control project as outlined in the 10-year plan scoped of work.
