Superintendent's Report - Bob Callaghan, Superintendent

Capturing Kids' Hearts and Leadership Blueprint Training (The Flippen Group) – Callaghan shared the percentage of certified staff (by building) trained in Capturing Kids' Hearts, and gave information on the upcoming CKH training (July 17 – 18, 2017). He noted the number of administrative staff to be trained in Leadership Blueprint (July 27 – 28, 2017) and informed the board that other districts will participate and share the costs.

Back to School – Callaghan provided important back to school dates including New Teacher Academy (August 15 – 17), New Teacher Breakfast (August 15), New Teacher Luncheon (August 16), Convocation (August 21), Back to School Nights (August 22), and First Day of School (August 24). A calendar of events will be sent to board members.

Enrollment and Registration Numbers – Callaghan shared a student enrollment summary report dated July 24, 2017. Elementary numbers (K-4) are at 1,172 with secondary (5-12) at 1,842 for a total of 3,014 students currently enrolled. Tina Ross provided a pie chart of online registration numbers showing 60.1% applications submitted, 38.6% applications remaining, and 0.3% applications in progress.
