#### **Student Transiency**

Superintendent Bob Callaghan presented a student transiency report for those students who have either left the district, or entered the district since the October 1, 2016 certified enrollment count date. The report showed a net increase of 26 students.

## **Update on Bond Project**

Superintendent Bob Callaghan gave an update on the new 5-8 middle school. User groups have been meeting, with FRK utilizing feedback to update the schematic design which will be presented to the construction committee, and then to the school board for approval on December 12, 2016.

#### **STEM Innovation Presentation**

Karla Cazett, Tim Hemann, Justin Liston, Jodi Morgan-Peters, and Tanya Michener introduced board members to the FLEDGE Program – "Where Innovation Takes Flight", a partnership between local business/workforce and school to be implemented in the fall of 2017. The STEM Committee is seeking funds for in the amount of \$29,000 to create an innovative classroom at Newton High School. A new FLEDGE Innovator course will be proposed for next year's academic handbook.

# Discussion Regarding Special Education Student Services, Staffing, and Funding

Tina Ross, Director of Special Programs and Board Members Ann Leonard and Robyn Friedman facilitated discussion brainstorming various topics regarding special education to address at a future board work session.

### IASB - Promise of Iowa - Support of Public Education Resolution

Board Member Donna Cook read the Promise of Iowa public education campaign resolution of support. Superintendent Bob Callaghan shared the launch video and website (<a href="www.promiseiowa.org">www.promiseiowa.org</a>). After discussion, the board requested this be an action item at a future board meeting. Callaghan shared plans for an upcoming luncheon on 2017 Iowa Legislative priorities.

# Consideration of Sealed Bids Opened and Reviewed by the Superintendent of Schools, Secretary of the Board, and the Financial Advisor – ACTION #10052

Jenny Blankenship and Jen Smith from Public Financial Management (PFM) were present to share the tabulation of bids for the Newton Community School District \$10,000,000 General Obligation School Bonds, Series 2016. The district received an "A1" rating from Moody's Investors Service. It was proposed that the formal award go to CitiGroup Global Markets, Inc. with a resulting purchase price of \$9,912,871.84, interest rate of 2.5703%, and net interest cost of \$2,277,245.66. Elbert moved, Friedman seconded to approve the resolution directing the sale of \$10,000,000 General Obligation School Bonds, Series 2016 and that the bid for the bonds determined to be the best and most favorable should be awarded to CitiGroup Global Markets, Inc. for a purchase price of \$9,912,871.84, net interest cost of \$2,277,245.66 and true interest cost of 2.5703%.
